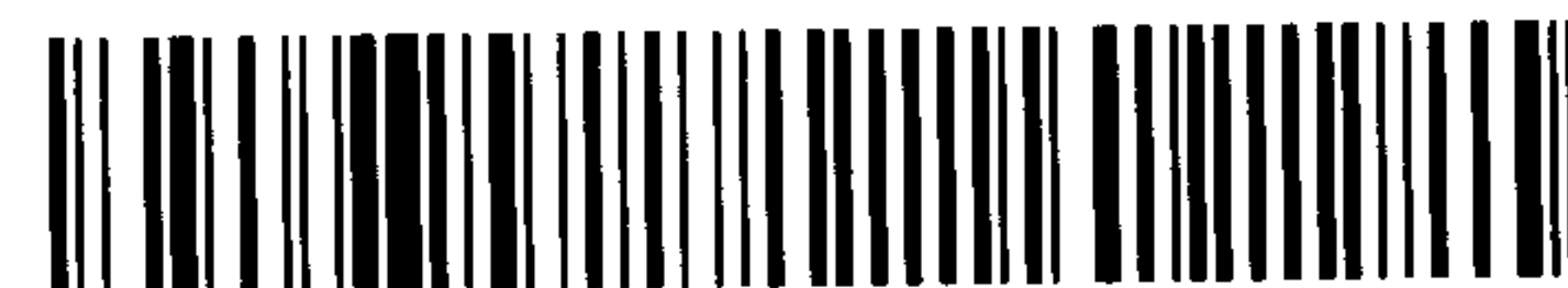

MEMORANDUM OF ANTENNA SITE AGREEMENT

This memorandum evidences that a lease was made and entered into by written ANTENNA SITE AGREEMENT dated March 21, 2005 between **SBA TOWERS, INC.**, a Florida corporation, ("Owner") and **SPRINT SPECTRUM L.P.**, a Delaware limited partnership, ("Tenant"), the terms and conditions of which are incorporated herein by reference.
