Know All Men by These Presents: That in consideration of **One hundred seventy three thousand** four hundred and no/100 (\$173,400.00) to the undersigned grantor, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, J. B. Nix Homebuilders, Inc. (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Ric L. Pevey and** Carolyn S. Pevey (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby** County, Alabama, to-wit:
