KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on November 20, 2003, **Evan W Clemmons, unmarried, Party of the First Part**, executed a certain mortgage to **Hamilton Mortgage Corporation**, which said mortgage is recorded in Instrument No. 20031126000774690, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to Mortgage Electronic Registration Systems, Inc; and Instrument No

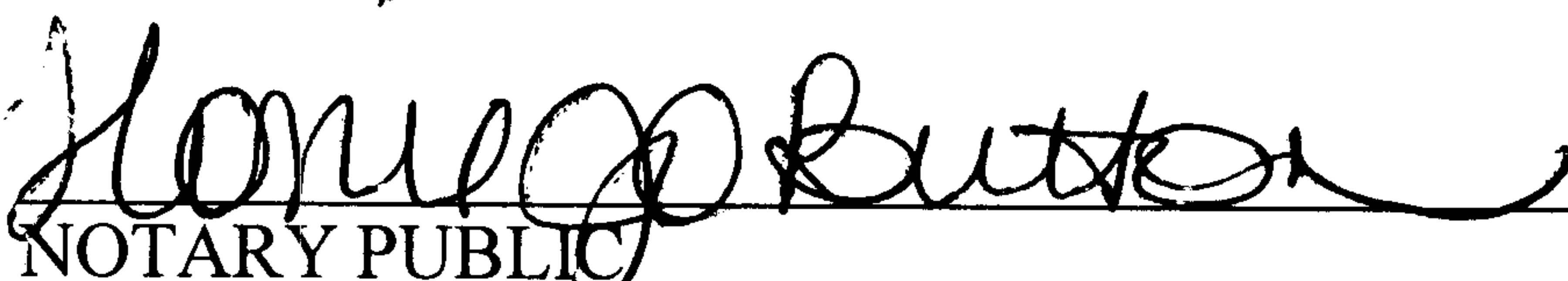
