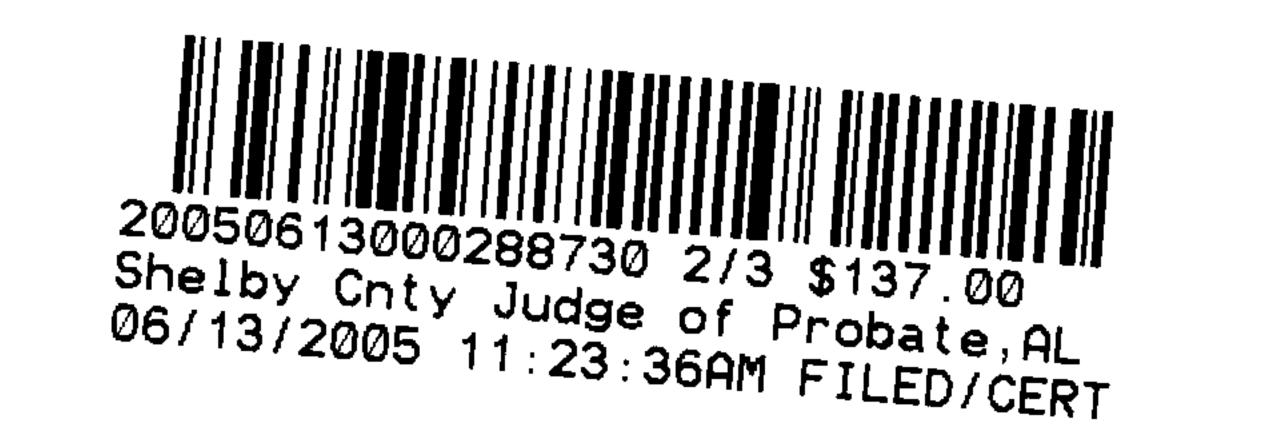

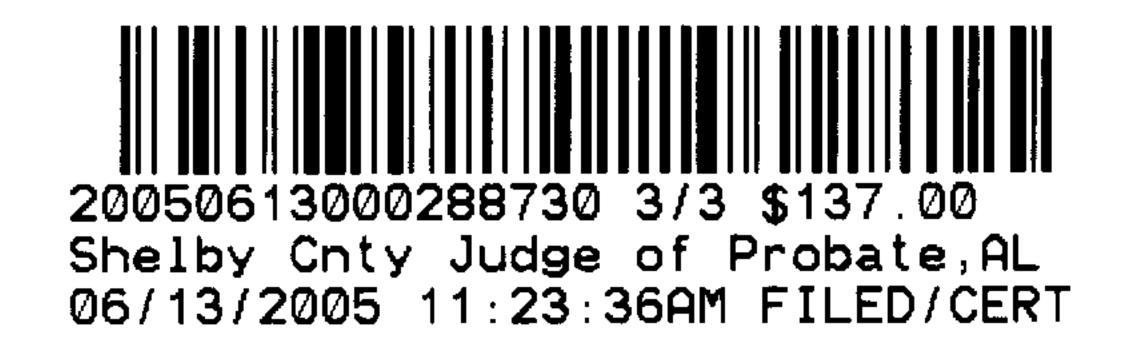

PROPERTY DESCRIPTION:
