MEMORANDUM OF GROUND LEASE

This Memorandum of Ground Lease (the "Memorandum of Lease") is made by and between Sherman Industries, Inc., an Alabama corporation ("Lessor") and Hanson Pipe and Products Southeast, Inc., a Delaware corporation ("Lessee") as of June 17, 2005.

RECITALS:

Lessor and Lessee entered into a Ground Lease dated as of June 17th, 2005 (the "Lease") pursuant to which Lessee leased from Lessor the land in Shelby County, Alabama described on **Exhibit A** attached hereto and made a part hereof (the "Land"). Lessor and Lessee have executed and recorded this Memorandum of Lease for the purpose of giving public notice of the existence of the Lease and its contents.

NOW, THEREFORE, for and in consideration of the premises and for other good and valuable consideration, all as more particularly set forth in the Lease, Lessor and Lessee do hereby state and agree as follows:

- 1. <u>Term.</u> The term of the Lease began on June 17, 2005 and expires at midnight on June 17, 2104 (the "Term").
- 2. Option. The Lease grants Lessee an option to purchase the Land.
- Easements. The Lease grants Lessee (i) an easement for access over the area shown on Exhibit B attached hereto and made a part hereof and an easement for fuel tanks within a portion thereof and (ii) an easement for a setback area together with the right to prohibit the construction and installation of buildings and other structures in the area shown on Exhibit C attached hereto and made a part hereof.
- 4. <u>Incorporation of Terms</u>. All of the terms and provisions contained in the Lease are hereby ratified and confirmed and are incorporated herein by reference in the same manner and to the same extent as if all of such terms and provisions were expressly set forth herein; and nothing contained in this Memorandum of Lease shall alter,

modify or amend in any manner whatsoever any of the terms or provisions contained in the Lease.

5. <u>Counterparts</u>. This Memorandum of Lease may be executed in multiple counterparts, each of which shall be an original and which taken together, shall constitute one Memorandum of Lease.




EXHIBIT B

Description of Easement Area

A 50' Wide Easement situated in the SW 1/4 of the NE 1/4 of Section 14, Township 20 South, Range 3 West, Shelby County, Alabama and being more particularly described as follows:

Commence at the NW Corner of the SE 1/4 of the NW 1/4 of said Section 14; thence run East along the North line of said 1/4-1/4 section for a distance of 1018.33 feet; thence turn 90°19′28″ right, for a distance of 134.53 feet; thence turn 90°23′46″ left, for a distance of 304.36 feet; thence turn 93°00′06″ left, for a distance of 211.23 feet to the POINT OF BEGINNING; thence continue along the last described course, for a distance of 214.70 feet to the northerly right of way line of Industrial Park Drive (50′ ROW); thence turn 90°00′27″ left and run along said right of way for a distance of 50.00 feet; thence turn 89°59′33″ left and leaving said right of way for a distance of 216.15 feet; thence turn 91°39′43″ left, for a distance of 50.02 feet to the POINT OF BEGINNING.




EXHIBIT C

Description of Setback Easement Area

A 10' Easement situated in the SE 1/4 of the NW 1/4 of Section 14, Township 20 South, Range 3 West, Shelby County, Alabama and being more particularly described as follows:

Commence at the NW Corner of the SE 1/4 of the NW 1/4 of said Section 14; thence run East along the North line of said 1/4-1/4 section, a distance of 1018.33 feet; thence turn 90°19'28" right for a distance of 87.35 feet to the POINT OF BEGINNING; thence continue along the last described course, for a distance of 47.18 feet; thence turn 90°23'46" left, for a distance of 227.97 feet; thence turn 90°00'00" right, for a distance of 10.00 feet; thence turn 90°00'00" right, for a distance of 237.97 feet; thence turn 90°23'46" right, for a distance of 57.18 feet; thence turn 90°00'00" right, for a distance of 10.00 feet to the POINT OF BEGINNING.
