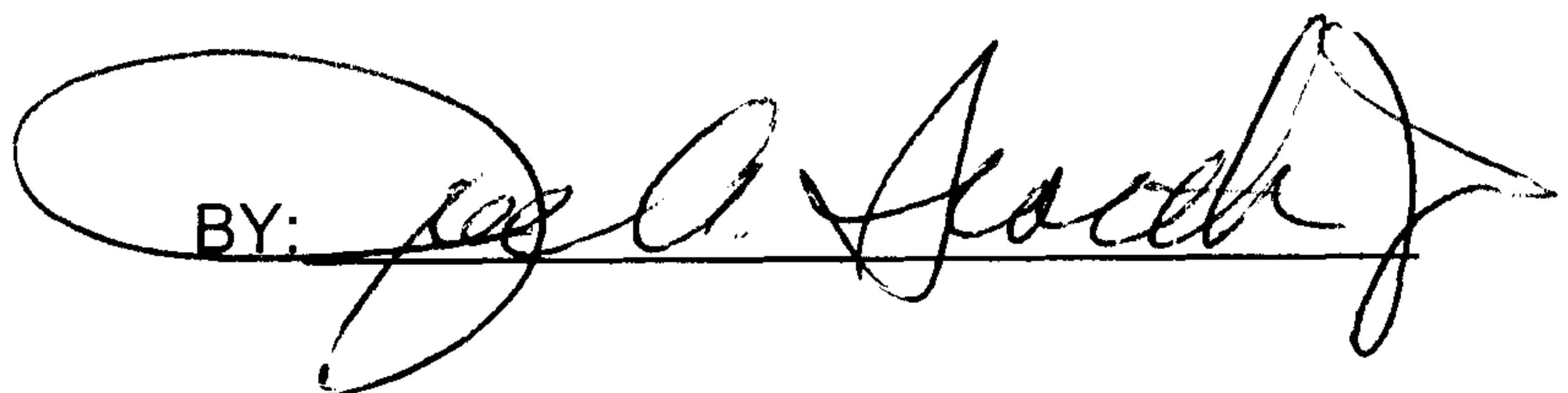

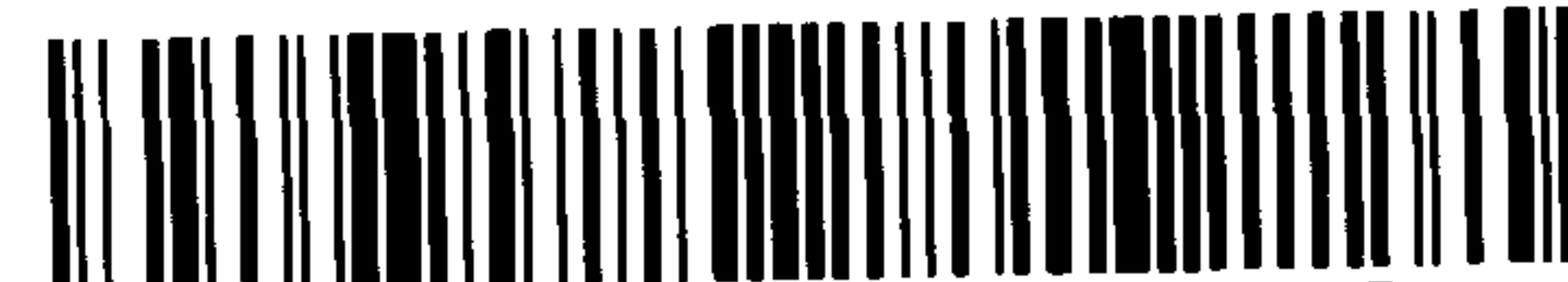
TO HAVE AND TO HOLD to the said Grantee, his, her or their heirs, or its successors and assigns forever.
