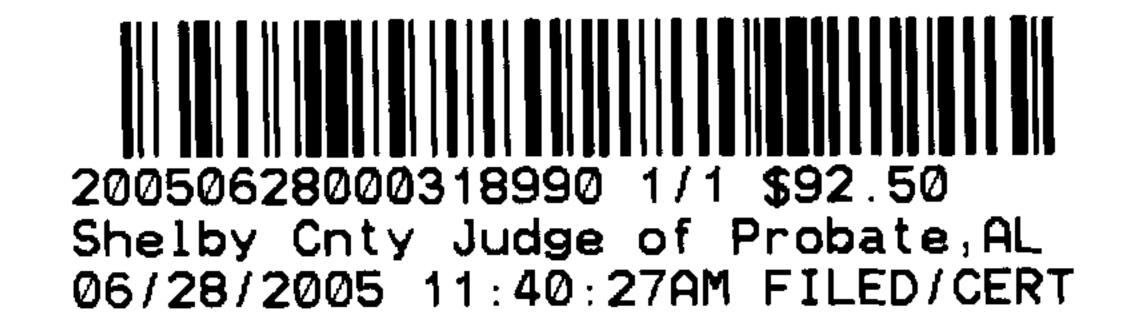

That in consideration of Ten Dollars and other good and valuable consideration to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, Building Resources, Inc., a corporation (herein referred to as grantors) do grant, bargain, sell and convey unto Sarah W. Schroeter and Mark Schroeter (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in SHELBY County, Alabama to-wit:
