

Know All Men by These Presents: That in consideration of TWO HUNDRED TWENTY ONE THOUSAND AND NO/100 DOLLARS (\$221,000.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, SHELBY HOMEBUILDERS, INC. herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto ALAN G. WATTS AND TAMELA A. WATTS (herein referred to as grantees, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 106, according to the Survey of Final Plat Long Branch Estates, Phase 1, as recorded in Map Book 34, page 66, in the Probate Office of Shelby County, Alabama.

Subject to:
