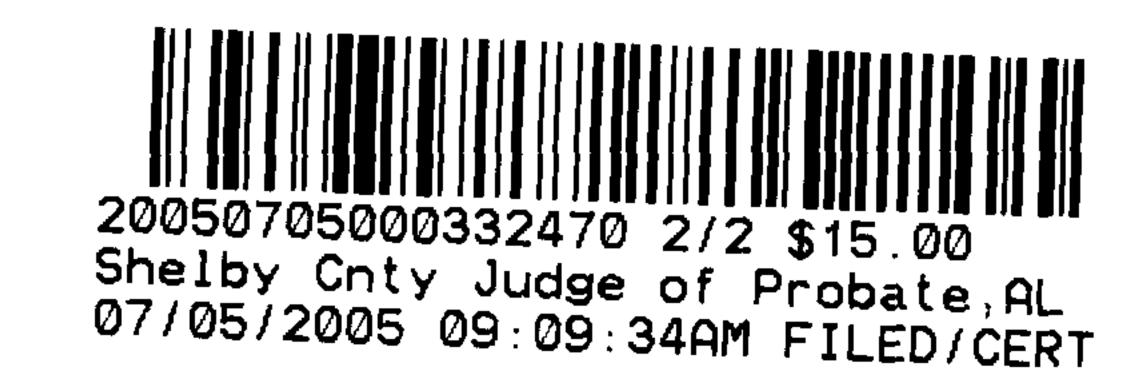
WARRANTY DEED
