


EXHIBIT "A"

Commence at the Northwest corner of the Southeast ½ of Southwest ½ of the Southwest ½ of Section 14 go South 01°43′16" East along the West boundary of said ½ ½ section for 242.10 feet to a point on a curve to the right on the Northerly boundary of Highway 52, said curve having a central angle of 46°22′58" and a radius of 632.72 feet; thence Southeasterly along said curve 512.20 feet to the Westerly boundary of Tenneyson Drive; thence (5) five courses along said Westerly boundary as follows - go North 02°56′51" East for 166.62 feet to the beginning of a curve to the right, having a central angle of 24°46′23" and a radius of 275.44 feet; thence Northerly along said curve 119.09 feet to the point of tangent; thence North 27°43′13" East for 36.01 feet to the beginning of a curve to the left, having a central angle of 45°34′40" and a radius of 205.37 feet; thence Northeasterly along said curve for 163.37 feet to the point of tangent; thence North 17°51′26" West for 57.56 feet to the North boundary of said ½ ½ % section; thence South 89°57′00" West for 469.95 feet to the point of beginning.
