A Parcel of land situated in the Northeast 1/4 of Section 36, Township 19 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows:

Commence at the Northeast corner of said Section 36; thence run South along the East line of said Section 36 a distance of 266.80 feet; thence turn 117 degrees, 40 minutes, 00 seconds right and run Northwesterly 165.21 feet to a point on the Westerly right of way line of U.S. Highway 31; thence turn 110 degrees, 54 minutes, 05 seconds left to the tangent of a curve to the left, said curve having a radius of 1,752.68 feet and run along the arc of said curve and said road right of way 86.93 feet to a point; thence turn 90 degrees, 00 minutes, 00 seconds left from the tangent to said curve at said point and run Easterly along said road right of way 15.00 feet; thence turn 90 degrees, 00 minutes, 00 seconds right to the tangent of a curve to the left, said curve having a radius of 1,737.68 feet and run along the arc of said curve and said right of way 189.15 feet to the point of beginning; thence continue along the last described course and and along said road right of way 113.00 feet to a point; thence turn 82 degrees, 08 minutes, 35 seconds right from the tangent to said curve at said point and run Southwesterly 211.53 feet; thence turn 90 degrees, 00 minutes, 00 seconds right and run Northwesterly 177.28 feet; thence turn 105 degrees, 57 minutes, 15 seconds right and run 239.84 feet to the point of beginning.
