KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Nine Thousand & 00/100 Dollars (\$9,000.00) and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, that, Carl C. Lucas, a widower and the sole surviving grantee on the last deeds of record; the other grantee, Martha B. Lucas having died on December 20, 2001, hereinafter called "Grantors", do hereby GRANT, BARGAIN, SELL AND CONVEY unto Carl C. Lucas, widower, Ronald C. Lucas and wife, Joy P. Lucas, hereinafter called "Grantees" for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to wit:
