## GENERAL POWER OF ATTORNEY — CERTIFIED COPY

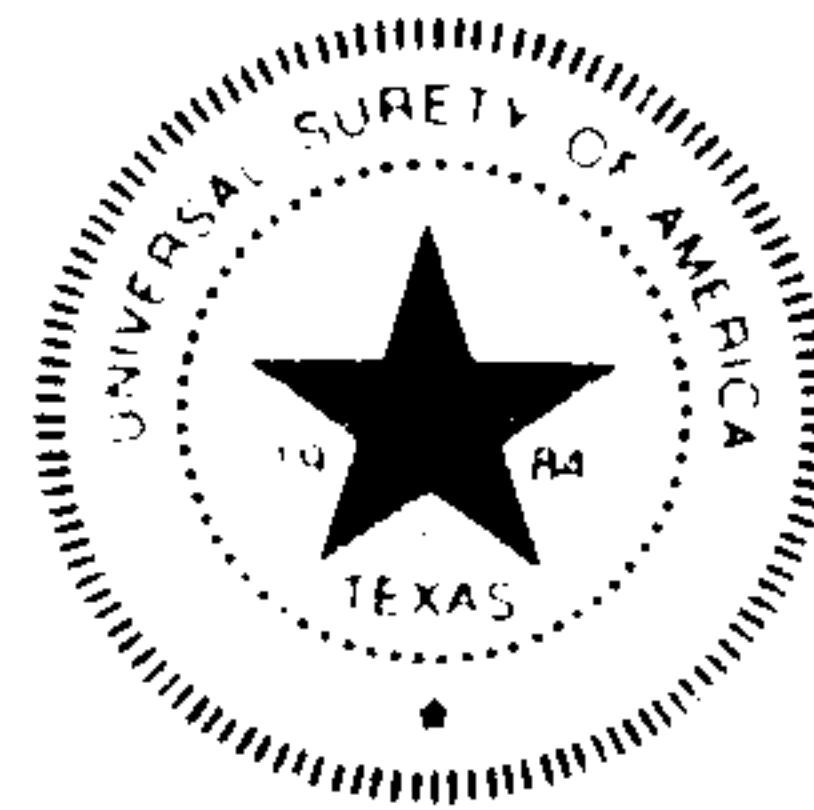

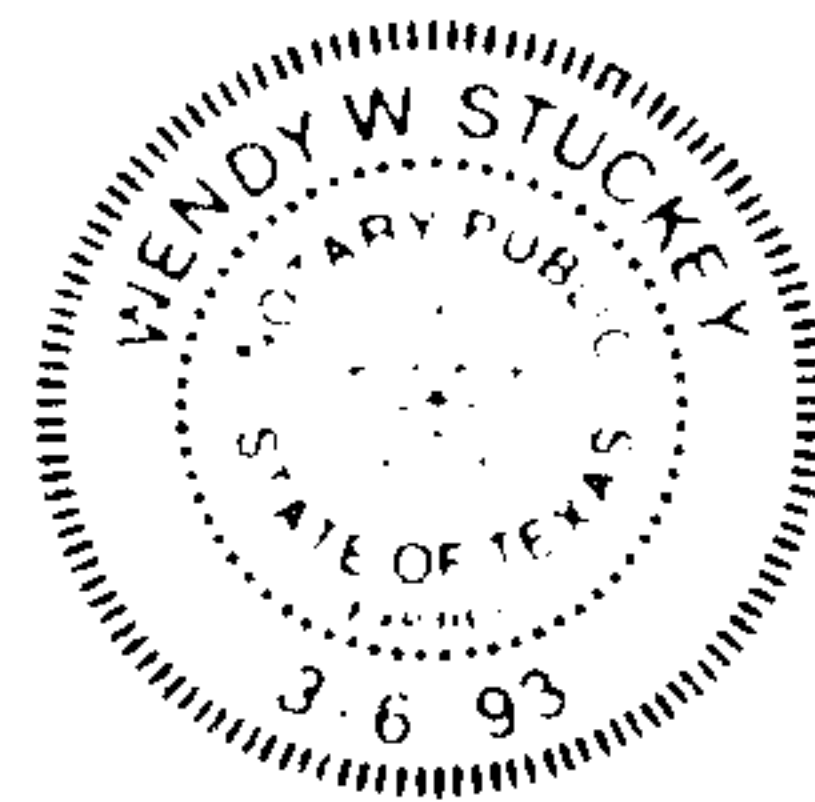

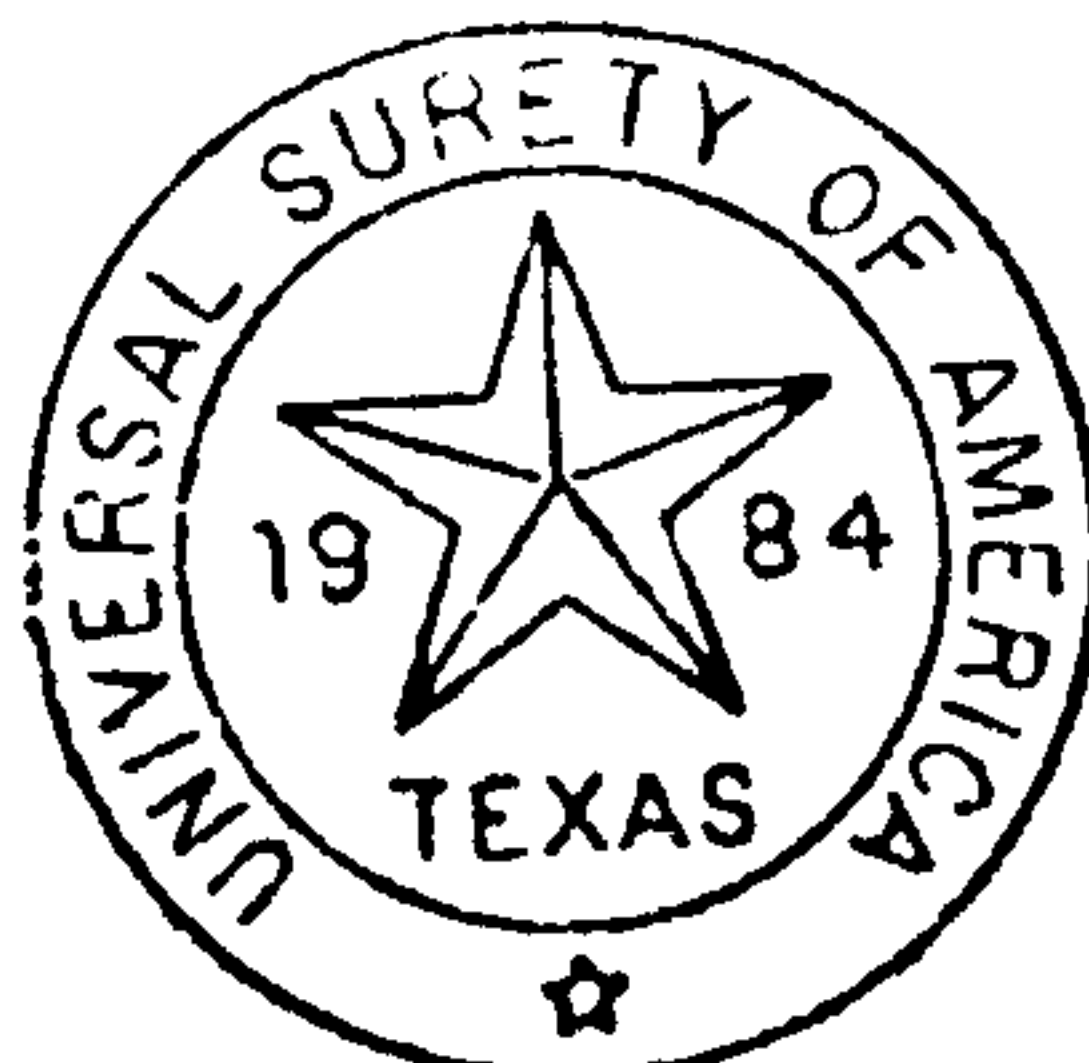
