KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of ten and No/100 dollars (\$10.00) and other good and valuable considerations to the undersigned, TOMMYE R. WORKMAN, Trustee, or her successor in trust under the Crim Living Trust dated December 5, 2001, and any amendments thereto (hereinafter referred to as the "Grantors"), in hand paid by JAMES LOUIS WORKMAN and TOMMYE R. WORKMAN as tenants in common (hereinafter referred to as the "Grantees"), the receipt of which is hereby acknowledged, the said Grantors do by these presents grant, bargain, sell and convey unto the said Grantees all of their right, title, and interest in and to that certain real estate situated in Shelby County, Alabama, (the "Property"):

Beginning at the NW corner of Section 31, Township 21 South, Range 2 West; thence run easterly along the North line of said section, a distance or 50.03 feet; thence turn right an angle of 88 degrees 08 minutes, and run southerly 427.6 feet to the North R.O.W. of a Shelby County paved road; thence turn right an angle of 99 degrees 02 minutes and run northwesterly along said R.O.W. 50.7 feet; thence turn right and an angle of 80 degrees 58 minutes and run northerly 421.19 feet to the point of beginning. This being a part of the NW 1/4 of the NW 1/4 of Section 31, Township 21 South, Range 2 West, Shelby County, Alabama.

The Grantors, do individually and for the heirs, executors, and administrators of the Grantors covenant with said Grantee and the heirs and assigns of the Grantee, that the Grantors are lawfully seized in fee simple of said premises; that said premises are free from all encumbrances, unless otherwise noted above; that the Grantors have a good right to sell and convey the said premises; that the Grantors and the heirs, executors, administrators of the Grantors shall warrant and defend the said premises to the Grantee and the heirs and assigns of the Grantee forever, against the lawful claims of all persons.
