Subdivision in which I have an interest.

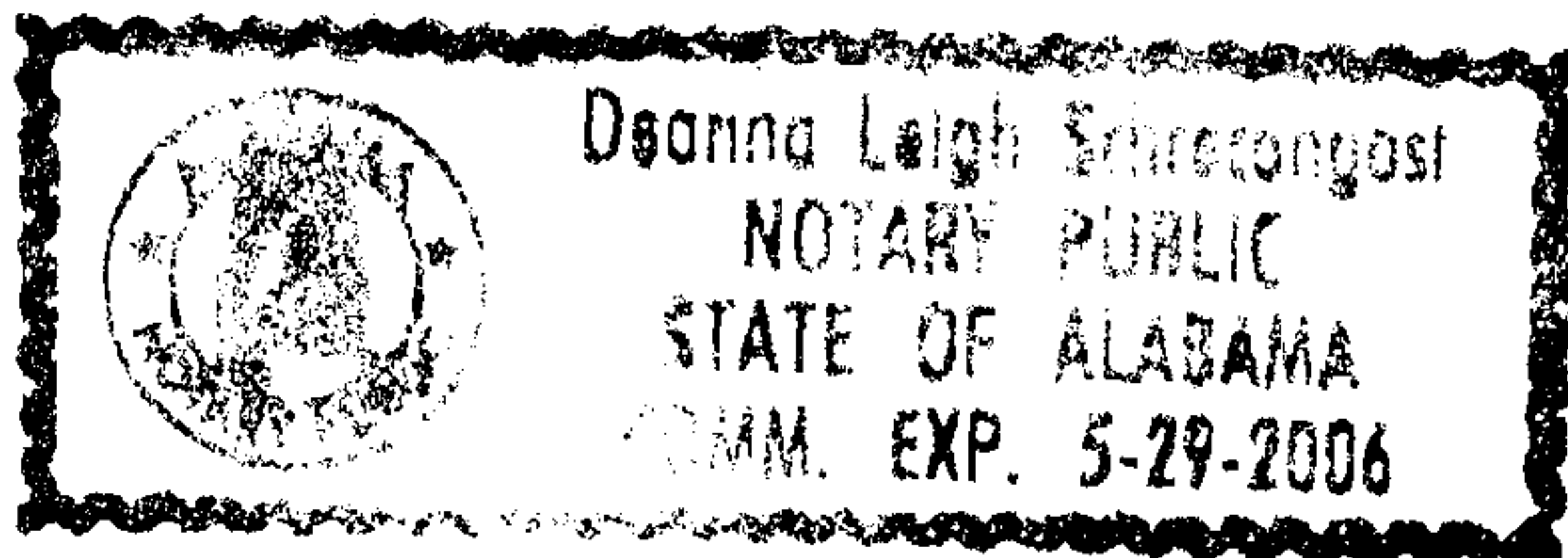
