Commence at the SE corner of Section 31, Township 21 South, Range 1 East, Shelby County, Alabama; thence North 89 degrees 57 minutes 50 seconds West along the South line of said section a distance of 622.40 feet; thence North 3 degrees 35 minutes 29 seconds West a distance of 474.22 feet to the POINT OF BEGINNING; thence North 84 degrees 17 minutes 41 seconds West a distance of 518.59 feet to the southerly right of way of Shelby County Highway 78; thence South 78 degrees 28 minutes 47 seconds East along said right of way a distance of 418.72 feet to a point of curve to the left having a central angle of 01 degree 01 minute 24 seconds and a radius of 1279.24 feet; thence along the arc of said curve and along said right of way a distance of 22.85 feet; thence South 3 degrees 35 minutes 29 seconds West and leaving said right of way a distance of 474.22 feet to the POINT OF BEGINNING.
