WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of other good and valuable considerations and the sum of One Hundred Eighteen Thousand and 00/100 Dollars (\$118,000.00) to the undersigned GRANTORS in hand paid by the GRANTEE herein, the receipt of which is hereby acknowledged, Robert Allen Sims, Jr. and wife, Kelly Doyle and Joseph A. Doyle, a married man (hereinafter referred to as GRANTORS), do hereby grant, bargain, sell and convey unto Kenneth W. Bolling, an unmarried man (hereinafter referred to as the GRANTEE), the following described real estate situated in the County of Shelby and State of Alabama, to-wit:

Lot 51, according to the survey of Phase One Hidden Creek Townhomes, as recorded in Map Book 27, Page 49, in the Office of the Judge of Probate of Shelby County, Alabama.

Note: \$116,176.00 of the above purchase price is in the form of a mortgage in favor of New South Federal Savings Bank, executed and recorded simultaneously herewith. This is not the homestead property of the Grantor, Joseph A. Doyle, as defined in the Code of Alabama §6-10-3. Kelly Doyle and Kelly Sims are one and the same person.

And said GRANTORS do for themselves, their successors and assigns covenant with the said GRANTEE, his heirs and assigns, that GRANTORS are lawfully seized in fee simple of said premises, that they are free from all encumbrances, unless otherwise noted above, that they are entitled to the immediate possession thereof; that GRANTORS have a good right to sell and convey the same as aforesaid; that GRANTORS will and their heirs and assigns shall, warrant and defend the same to the said GRANTEE, their heirs and assigns forever, against the lawful claims of all persons.
