KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 6th day of August, 2002, John W. Smith, a single person, executed that certain mortgage on real property hereinafter described to Coats & Co., Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. 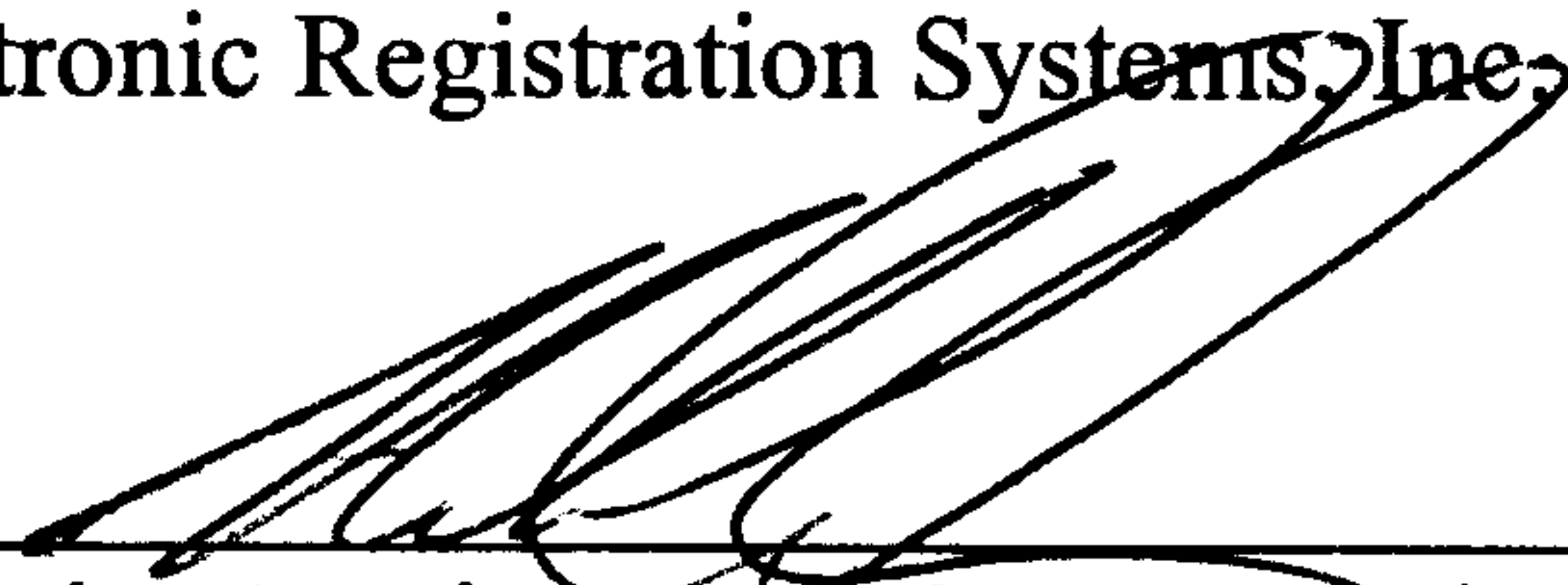

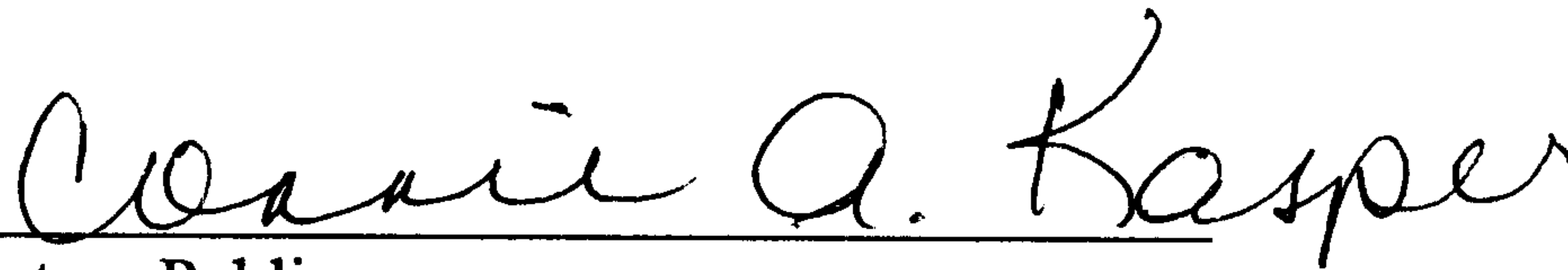
