## DISCLAIMER AND RENUNCIATION

WHEREAS, Wilbur Jackson James, Jr. (the "Deceased") died testate on or about the 28<sup>th</sup> day of November, 2004, domiciled in Shelby County, State of Alabama, leaving a Will, which was duly admitted to probate in the Probate Court of Jefferson County on the 8<sup>th</sup> day of December, 2004.

WHEREAS, the Deceased was survived by his wife, Perry Lawler James.

WHEREAS, Paragraph 6.2(a) of the Deceased's Last Will and Testament (said Will having been admitted to record in the Probate Court of Shelby County, Case No. PR-2004-000666) appoints the Deceased's wife, Perry Lawler James, as trustee of the Family Trust created under Article Four of the Deceased's Last Will and Testament;

WHEREAS, pursuant to beneficiary designation on record with Charles Schwab, the Deceased named (i) his wife, Perry Lawler James, as primary beneficiary of his Schwab IRA Account No. 1063-0081 (the "Deceased's IRA"); (ii) the trustee of said Family Trust as contingent beneficiary if his wife, Perry Lawler James, disclaims a fractional interest of the Deceased's IRA, and (iii) his children, Vanessa J. Bragg and Christopher Jackson James, as second contingent beneficiary if the trustee of said Family Trust disclaims a fractional interest of the Deceased's IRA;

WHEREAS, Perry L. James (the "First Disclaimant") desires to disclaim a fractional interest of the Deceased's IRA;

WHEREAS, Perry L. James, as trustee of the Family Trust created under the Deceased's Will, (the "Second Disclaimant") desires to disclaim the entire fractional interest of the Deceased's IRA that becomes payable to the Family Trust as a result of disclaimer by the First Disclaimant.

NOW THEREFORE, premises considered, in accordance with the Alabama Uniform Disclaimer of Property Interests Act, Code of Alabama, Sections 43-8-290 to 43-8-298, (the "Act"), and in accordance with Section 2518 of the Internal Revenue Code of 1986, as amended the First Disclaimant does by this instrument definitely and finally disclaims, renounces and refuses to accept seven percent (7%) of the value of the Deceased's IRA (Charles Schwab Account No. 1063-0081), and the Second Disclaimant does by this instrument definitely and finally disclaims, renounces and refuses to accept the entire seven percent (7%) of the value of the Deceased's IRA (Charles Schwab Account No. 1063-0081) herein disclaimed by the First Disclaimant.
