## STATUTORY WARRANTY DEED

KNOW ALL PERSONS BY THESE PRESENTS, that in consideration of One Hundred Thirty Three Thousand Nine\_Hundred Dollars (\$133,900.00) to the undersigned Holland Lakes, Inc., an Alabama corporation ("Grantor"), in hand paid by John Coleman Hensley, Jr. ("Grantee"), the receipt and sufficiency of which are hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Grantee the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot <u>59</u>, according to the <u>Final Plat of Holland Lakes</u>, Sector One as recorded in Map Book 34 Page 85, in the Probate Office of Shelby County, Alabama (the "Property").

Together with the nonexclusive easement to use the Common Areas as more particularly described in Holland Place Declaration of Covenants, Conditions, and Restrictions executed by the Grantor and filed for record as Instrument No. 2005046000199570 in the Probate Office of Shelby County, Alabama (the "Declaration").


