Whereas, the attached written petition requesting that the above-noted property be annexed to the Town of Westover has been filed with the Westover town clerk; and

Whereas, said petition has been signed by the owner(s) of said property; and

Whereas, said petition contains (as Petition Exhibit A) an accurate description of said property together with a map of said property (Exhibit B) showing the relationship of said property to the corporate limits of Westover; and

ANNEXATION PETITION

TO: THE TOWN OF WESTOVER, ALABAMA, a municipal corporation

Comes now the undersigned, Alabama Power Company, being the owner of the property described on Exhibit "A" attached hereto, which said property described to the knowledge (without inquiry) of the undersigned representative of Alabama Power Company is located and contained within an area contiguous to the corporate limits of the Town of Westover, Alabama, which said property to the knowledge (without inquiry) of the undersigned representative of Alabama Power does not lie within the corporate limits of any other municipality. To the knowledge (without inquiry) of the undersigned representative of Alabama Power Company all of the said property which lies within the police jurisdiction of both the Town of Westover and another municipality, if any, is located closer to the Town of Westover than to the other municipality as required by 11-42-21, Code of Alabama 1975. Alabama Power Company requests that the property described on Exhibit "A" attached hereto be annexed to the said Town of Westover, Alabama, and further requests the town council of the Town of Westover, Alabama to adopt an ordinance assenting to the annexation of said property to the Town of Westover, Alabama so as to embrace said property and further providing that said property shall become a part of the corporate area of the Town of Westover, Alabama, upon the date of publication of the said ordinance.

The SW ½ of the SE ¼ of Section 23 in Township 19 South, Range 1 East lying north of U.S. Highway 280.


