- 2. Subject to all exceptions shown on Exhibit "A" of this deed.

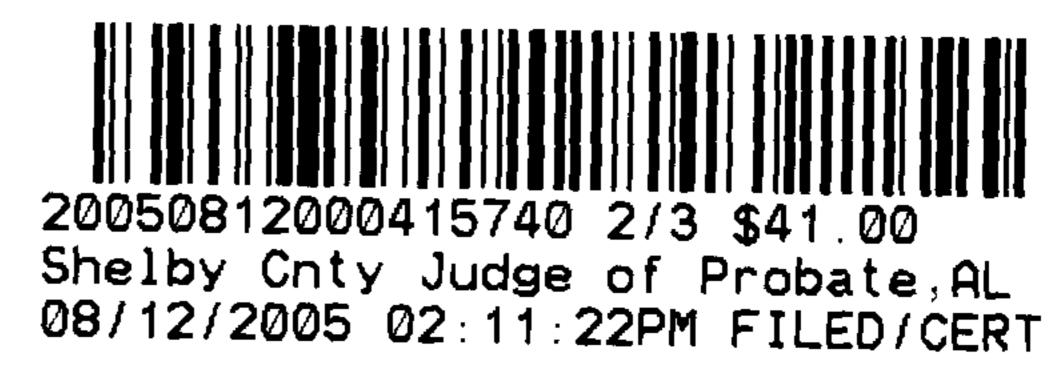
\$260000 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.

Schedule B-II

EXCEPTIONS

Part II. Schedule B of the policy or policies to be issued will contain exception to the following matters unless the same are disposed of to the satisfaction of the Company:

- Defects, liens, encumbrances, adverse claims or other matters, if any, created, first appearing in the public record of attaching subsequent to the effective date hereof but prior to the date the proposed Insured acquires for value of record the estate or interest or mortgage thereon covered by this Commitment.
- Rights or claim of parties in possession not shown by the public records.
- Easements, or claim of easements, not shown by the public records.
- Any liens, or right to a lien, for services, labor or material hereto or hereaster furnished, imposed by law and not shown by the public records.
- Discrepancies, conflicts in boundary lines, shortage in area, encroachments, and any facts which a correct survey and inspection of the premises would disclose and which are not shown by the public records.

Special Exceptions:

- The lien of Ad Valorem taxes for the year 2005 are a lien but neither due nor payable 6. until 1 October, 2005.
- Municipal improvements assessments and fire district dues against subject property, if any.
- Title to all oil, gas and minerals within and underlying the premises, together with all oil 8. and mining rights and other rights, privileges and immunities relating thereto, together with any release of liability for injury or damage to persons or property as a result of the exercise of such rights.
- Subject to Covenants, conditions and restrictions (deleting therefrom, any restrictions 9, indicating any preference, limitation or discrimination based on race, color, religion, sex, handicap, family status or national origin) as set forth in the document recorded in Instrument 20040518000261330 in the Probate Office of Shelby County, Alabama,
- 35 foot building line on front of subject property and 15 foot easement on rear as shown 10. on recorded map.
