ARTICLES OF MERGER
(Pursuant to Alabama Code Section 10-12-55)

1. Names of the domestic limited liability companies which are to merge are as follows: **CHECK EXCHANGE OF TARRANT, LLC** an Alabama Limited Liability Company shall be merged with and into **CHECK EXCHANGE OF ALABASTER, LLC** an Alabama Limited Liability Company to exist and be governed by the laws of the State of Alabama.
