## MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That whereas heretofore on to-wit: the 29<sup>th</sup> day of April, 2004, Susan D. 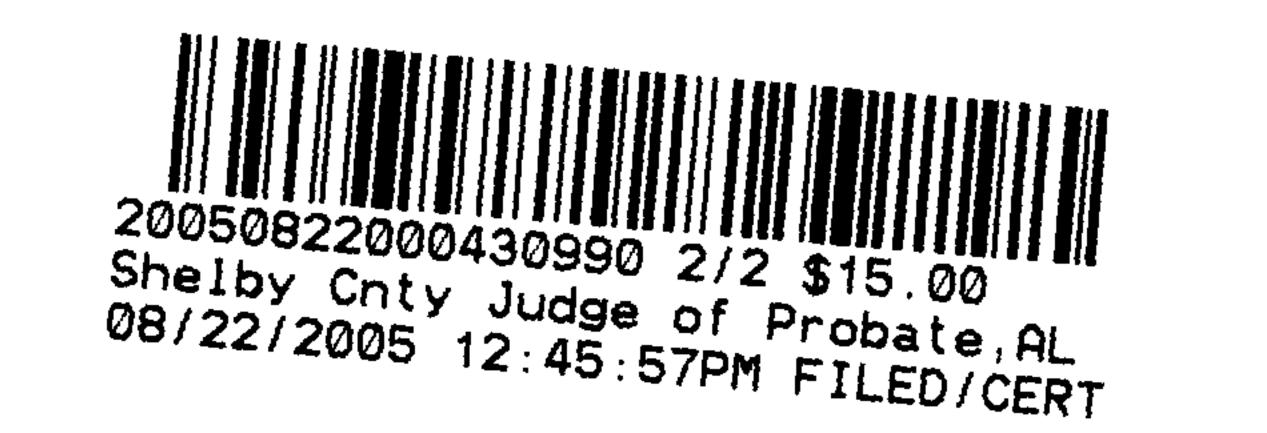
