KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One Hundred Forty-seven Thousand, Five Hundred Eighty-eight and 00/100 (\$147,588.00) Dollars, to the undersigned grantor in hand paid by the GRANTEE herein, the receipt whereof is acknowledged, the undersigned SHELBY COUNTY, ALABAMA, a political subdivision of the State of Alabama (herein referred to as grantor) does grant, bargain, sell and convey unto Realty, Inc. (herein referred to as GRANTEE), the following described real estate situated in Shelby County, Alabama to-wit:

Site 7D, according to the Map of a Re-subdivision of Site 7A, as recorded in Map Book 35, Page 31, being a Resurvey of Sites 5A and 7A (A Resurvey of Part of Sites 4, 5, 6A and 7, being a Resurvey of Site 6 and Lot 1-A-1-A-1, Shelby West Corporate Park), as recorded in Map Book 29, page 111, in the Probate office of Shelby County, Alabama; being situated in Shelby County, Alabama.

- (5) 25-foot rear building setback line on West side of said lot and 50-foot front building set back line on East side of said lot as shown on recorded map.

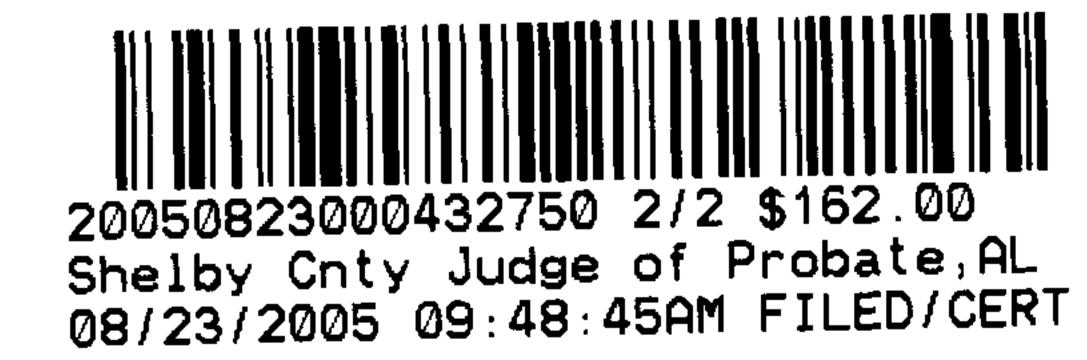
TO HAVE AND TO HOLD to the said grantee, its successors and assigns forever.
