

## CERTIFICATE OF TRUST

- 7. The Trust Agreement has not been revoked and there has been no amendments limiting the powers of the Trustees over trust property.
- 8. The Trustees pursuant to the terms of the Trust Agreement may convey property owned by the Trust to Edwards Specialties, Inc.; the execution of a deed of conveyance is authorized by the Trust.
- 9. No person or entity paying money to or delivering property to the Trustees shall be required to see its application. All persons relying on this document regarding the Trustees and their powers over trust property shall be held harmless for any resulting loss or liability from such reliance.
