## ARTICLES OF ORGANIZATION

OF

## OM PELHAM, LLC

AN ALABAMA LIMITED LIABILITY COMPANY

Pursuant to the provisions of the Alabama Limited Liability Company Act, as set forth in Sections 10-12-1, *et seq.* of the *Code of Alabama* (1975), as amended from time to time (the "Act"), the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

### ARTICLE I

#### Name

The name of the limited liability company is **OM PELHAM, LLC** (the "Company").

### ARTICLE II

#### Duration

The Company shall have a duration from the date of organization until it is dissolved and its affairs are wound up in accordance with the Act or the Company's Operating Agreement.

### ARTICLE III

#### Purposes

The objects and purposes for which the Company is formed are:

(a) To acquire, own, purchase, develop, invest in, deal in and with, hold, subdivide, manage, sell, operate, convey, lease, and sublease real and personal property of any kind or nature whatsoever, including interests in corporations, partnerships, and other limited liability companies;

(b) To borrow money and issue notes and other evidences of indebtedness with respect to the foregoing property, and to secure the payment and performance of its obligations thereunder by mortgage, deeds of trust, pledge, or otherwise with respect to said property;

(c) To engage in any and all transactions and activities necessary, appropriate, customary, convenient or incidental to any of the foregoing purposes, and to exercise all powers necessary to, or reasonably connected with the Company's business described above, which may be legally exercised by limited liability companies under the Act; and

(d) To engage in any other lawful act or activity which all of the members consent to in writing.

#### ARTICLE IV

##### Registered Office; Registered Agent

The location and mailing address of the initial registered office of the Company shall be 410 Oak Mtn. Circle, Pelham, Alabama 35124, and its registered agent at such address shall be Nilam Parikh.

#### ARTICLE V

##### Initial Member

#### ARTICLE VII

##### Right of the Members to Admit Additional Members

The members shall have the right to admit additional members into the Company only upon obtaining the unanimous written consent of the members thereto, and upon such other terms and conditions as may be set forth in the Company's Operating Agreement.

#### ARTICLE VIII

##### Effect of Cessation of Membership

The only circumstances under which the cessation of membership of one or more members will result



in the dissolution of the Company is when such cessation leaves no remaining member and there are no members going forward, unless either of the following applies:

(i) the holders of all of the financial rights in the Company agree in writing, within ninety (90) days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members;  
or

(ii) the legal existence and business of the Company is continued and one or more new members are appointed as members in the manner, if any, as may be stated in the Company's Operating Agreement.


## ARTICLE IX
