PURSUANT TO THE PROVISIONS OF THE ALABAMA BUSINESS CORPORATION ACT, THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I: The name of the corporation will be Kellis Vegetation Management, Inc.

**ARTICLE II:** The duration of the corporation shall be perpetual.

ARTICLE III: The corporation has been organized for the purpose of providing for-profit professional vegetation management.
