FIRST: I revoke all former wills and codicils that I previously made.

THIRD: In the event that my husband shall predecease or fail to survive me by sixty (60) days, I give all my estate to:

FIFTH: I name my husband IVAN NELSON MARLER to be personal representative (Executor) of this will. If he shall predecease me or decline, or for any reason fail to qualify or cease to act as personal representative, I name RICHARD WAYNE MARLER as personal representative, without bond, instead.

SIXTH: I hereby empower my Executor to sell property, real or personal, for cash or on time, without an order of Court, at such time and upon such terms and conditions as shall seem best.
