

## RIGHT OF FIRST REFUSAL


The undersigned being all the Owners of the following described real property (hereinafter "Grantor") hereby grant unto Lighthouse Investments, LLC, (hereinafter "Grantee") for the purchase of real property described as follows:

Lots 1, 2 & 3, according to the Suvey of Brett Subdivision, as recorded in Map Book 20, Page 37, in the Probate Office of Shelby County, Alabama.

a right of first refusal to purchase the property described above, from the Grantor at anytime within the next six (6) years from the date of conveyance of Lots 4, 5 & 6. Should the Grantor notify the Grantee of his intent to sell, in writing by certified mail prior to the end of six years, the Grantee shall have ten (10) days from the receipt of written notice of Grantor's intent to sell in order to respond to the Grantor that the Grantee desires to exercise the right of refusal. In the event the Grantee responds in writing that he desires to exercise the right of refusal, the Grantee shall have sixty (60) days from the date of giving written notice to the Grantor to purchase and close on the real property.

Grantor shall notify the Grantee of his intent to sell in writing by certified mail. The Grantee shall have sixty (60) days from the receipt of written notice of Grantor' intent to sell in order to close and purchase the property. In the event the Grantee does not respond within said sixty (60) days, the right of first refusal shall terminate.




