NOTICE OF STATUTORY MORTGAGE LIEN

Notice is hereby given, pursuant to Section 11-81-178 of the CODE OF ALABAMA 1975, as of the 23rd day of September, 2005, as follows:

1. The governing body of the City of Calera, Alabama (the "City"), has heretofore on September 19, 2005 adopted an ordinance authorizing the issuance of a \$4,600,000 Sewer Revenue Bond, Series 2005-A, and a \$3,200,000 Sewer Revenue Bond, Series 2005-B (collectively referred to as the "Bonds"), of the City under the provisions of Article 5 of Chapter 81 of Title 11 of the CODE OF ALABAMA 1975, for the purpose of financing the acquisition of and construction of improvements for a sanitary sewer system for the City.

2. The said system consists of facilities owned by the City for providing sanitary sewer service, including sewer pumping and treatment facilities, storage facilities, mains, services, meters, valves, hydrants, and appurtenant facilities, and real property and interests therein.

3. The said bonds are issued in the form of one fully registered bond in the principal amount of \$4,600,000, designated Sewer Revenue Bond, Series 2005-A, of even date, bearing interest at the rate of 4.125% per annum, and one single fully registered bond in the principal amount of \$3,200,000, designated Series 2005-B, of even date, bearing interest at the rate of 4.125% per annum, both bonds issued on a parity basis (with respect to the sewer revenues), payable annually on the first day of January in each year, and maturing on January 1 in the following principal amounts in the following years:

By virtue of the said laws of the State of Alabama and the ordinance authorizing the issuance of the said Bonds, a statutory mortgage lien on the said system, including any replacements thereto or extensions thereof and improvements or additions thereto, has been created in favor of the holder of the said Bonds and in favor of the holders of bonds issued in lieu of the said bonds, and in favor of the holders of any bonds issued pursuant to the aforesaid ordinance on a parity of lien with the said Bonds, and the said system shall remain subject to such statutory mortgage lien until payment in full of the principal of and interest on all such bonds, or until moneys sufficient for the payment of the principal thereof and interest thereon have been deposited in trust for the payment thereof.

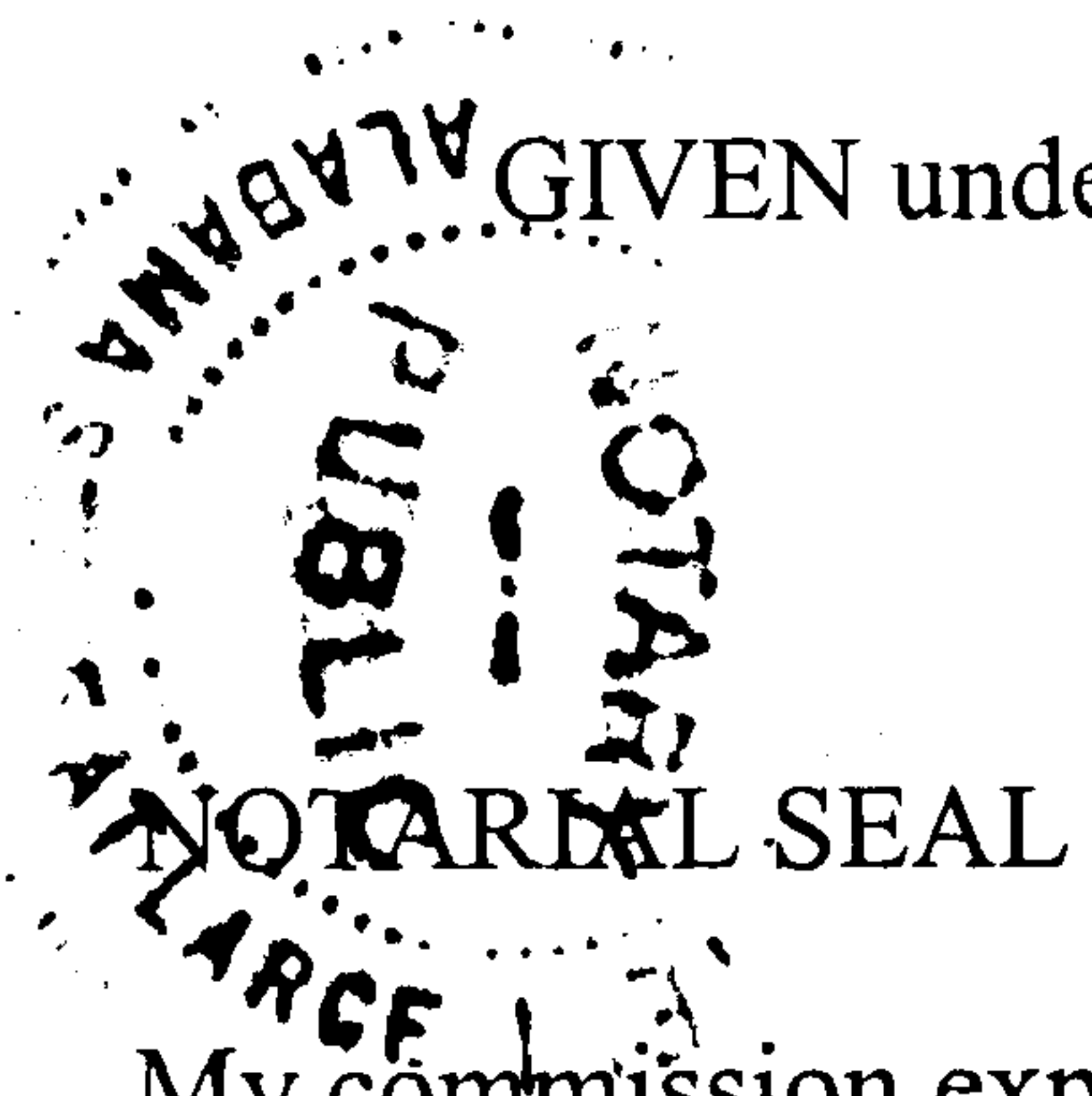
