KNOW ALL PERSONS BY THESE PRESENTS: That SHARMAN SAMUDIO and JIMMY SAMUDIO, husband and wife, did, on to-wit, May 7th, 1998, execute a mortgage to UNION PLANTERS BANK, NATIONAL ASSOCIATION, now REGIONS BANK SUCCESSOR BY MERGER TO UNION PLANTERS BANK, N.A., which mortgage is recorded in Instrument No. 1998-22711, et seq., in the Office of the Judge of Probate of SHELBY County, Alabama; and
