**LOAN MODIFICATION AGREEMENT TO THE
MORTGAGE(HOME EQUITY LINE OF CREDIT)**

This Loan Modification Agreement (the "Agreement"), made this **11th** day of **August**, **2005** between **GARY A. - **TO CORRECT THE DATE OF MORTGAGE FROM 10/20/2004 TO 10/08/2004 ON PAGE 1**
- **TO ADD THE BORROWERS ACKNOWLEDGEMENT TO THE CORRECTION ON PAGE 1 OF THE MORTGAGE**

The Borrowers shall comply with all other covenants, agreements and requirements of the Security Instrument. Nothing in this Agreement shall be understood or construed to be a satisfaction or release in whole or in part of the Security Instrument.


