GENERAL WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Two Hundred Seventy-Five Thousand and 00/100 (\$275,000.00), and other good and valuable consideration, this day in hand paid to the undersigned Richard B. Schilhab, and wife Kelly M. Schilhab, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEE herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEE, Flanders Gandy Russell, (hereinafter referred to as GRANTEE), his heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Unit 64, according to the Declaration of Condominium of Courtside at Brook Highland, A Condominium, recorded as Instrument No. 20020521000241450 in the Probate Office, as amended by the Amendment to Declaration dated May 8, 2002, recorded as Instrument No. 20020521000241460 and as further amended by the corrective amendment dated May 21, 2002, recorded as Instrument No. 20020521000241470 in said Probate Office as reflected in the Plan of Courtside at Brook Highland, a Condominium attached as Exhibit C to the said Declaration and separately recorded in Map Book 28, Page 103 in said Probate Office.
