Know All Men by These Presents: That in consideration of **ONE HUNDRED EIGHTY SIX THOUSAND AND NO/100 DOLLARS (\$186,000.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **RICHARD B. RYEL AND PATRICIA A. RYEL, HUSBAND AND WIFE** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **SHAAN RYEL AND SONDRA F. RYEL** (herein referred to as grantees, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 12, in Block 5, according to the Map and Survey of Indian Valley, 6th Sector, as recorded in Map Book 5, Page 118, in the Probate Office of Shelby County, Alabama.

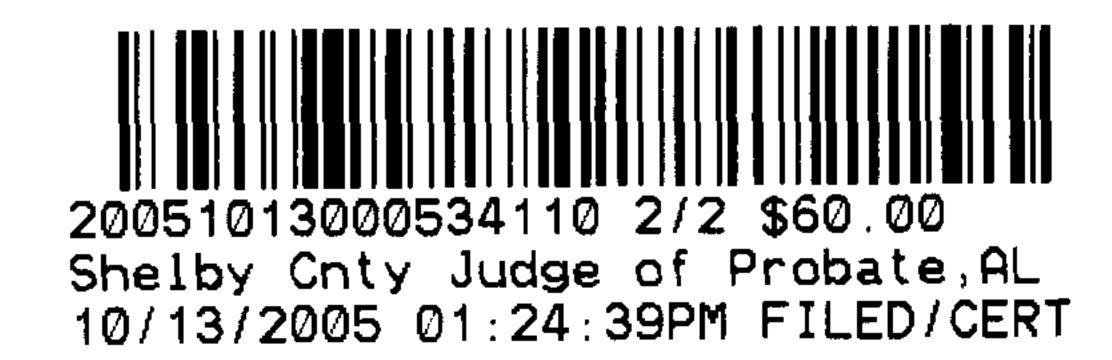
Subject to:

(1)Taxes or assessments for the year 2005 and subsequent years not yet due and payable; (2)Mineral and mining rights not owned by the Grantor (3) All easements, restrictions, covenants, and rights of way of record, including but not limited to: (a) 50-foot building setback line from Indian Lake Drive; 10-foot easement on rear lot line and Westerly lot line, as shown on recorded map of said subdivision (b) Right of Way to Alabama Power Company and Southern Bell Telephone & Telegraph Company recorded in Deed Book 107, Page 121, Deed Book 161, Page 493, Deed Book 102, Page 53 and Deed Book 104, Page 213 (c) Covenants, conditions, and restrictions as set forth in instrument document recorded in Misc. Book 2, page 298 and Misc. Book 2, page 885 and amended restrictions recorded in Misc. Book 9, Page 143 (d) Easement to "The Five Ts" recorded in Deed Book 284, Page 885 (e) Reservation of mineral and mining rights in the instrument recorded in Deed Book 181, Page 385, together with the appurtenant rights to use the surface. And I (we) do, for myself (ourselves) and for my (our) heirs, executors and administrators, covenant with said grantee, his, her or their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are fee from encumbrances, unless otherwise stated above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will, and my (our) heirs, executors and administrators shall warrant and defend the same to the said grantees, his, her or their heirs and assigns forever, against the lawful claims of all persons.
