Bailey, John H. Grindrat and Samuel B. Jones, assignees, as aforesaid, all the estate, real and personal of the said Alabama and Chattanooga Rail Road Company bankrupt aforesaid including all the property of whatever kind of which it is possessed or in which it is interested or entitled to have on the 6th day of November A.D. 1871 with all its deeds books and papers relating thereto excepting such property as is exempted from the operation of this assignment by the said fourteenth section of said act. In trust, nevertheless, for the use and purposes with the powers, and subject to the conditions and limitations set forth in said act.
