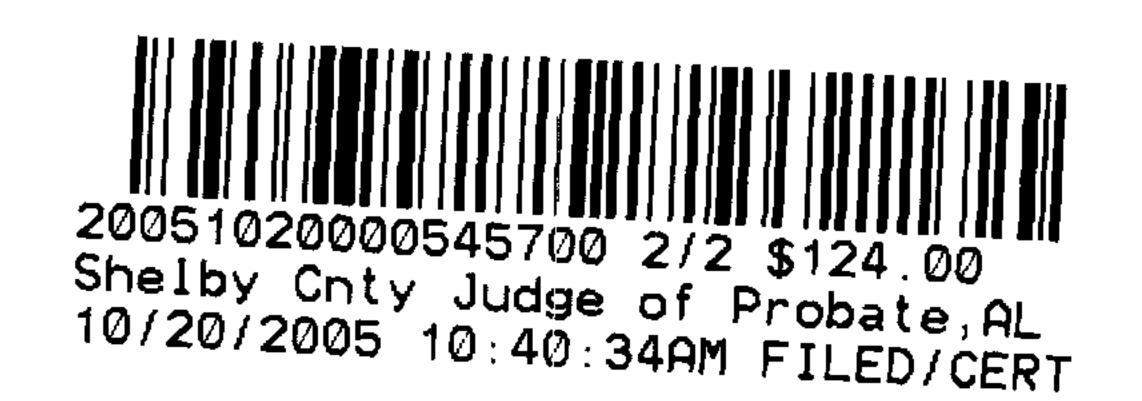

## EXHIBIT "A" LEGAL DESCRIPTION



Commence at a chain link fence post in place accepted as the Northwest corner of the Northeast ¼ of the Northwest ¼ of Section 2, Township 22 South, Range 3 West, Shelby County, Alabama; thence proceed South 85 deg. 45 min. 44 sec. East along the North boundary of said  $\frac{1}{4}$ - $\frac{1}{4}$  section for a distance of 1320.20 feet to a point on the Easterly right of way of Shelby County Highway No. 119; thence proceed South 00 deg. 08 min. 23 sec. West for a distance of 240.29 feet to a ¾ inch pipe in place being a point on the Easterly right of way of said road, said point also being the point of beginning. From this beginning point proceed South 87 deg. 07 min. 15 sec. East for a distance of 561.57 feet to a ½ inch crimp top pipe in place; thence proceed South 00 deg. 53 min. 41 sec. West along the West boundary of Lot 8, Lot No. 7 and Lot No. 6 of the Meadow Green Subdivision as shown by map of said subdivision on record in the Office of the Judge of Probate of Shelby County, Alabama, in Map Book 6 at Page 59 for a distance of 310.93 feet to a tree at location of corner; thence proceed North 87 deg. 18 min. 36 sec. West along the North boundaries of Lot No. 5, Lot No. 4, Lot No. 3, Lot No. 2 and Lot No. 1 of said subdivision for a distance of 557.39 feet to a ½ inch crimp top pipe in place being located on the Easterly right of way of said road; thence proceed North 00 deg. 08 min. 23 sec. East along the Easterly right of way of said road for a distance of 312.94 feet to the point of beginning, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
