


## OVERALL PARCEL LEGAL DESCRIPTION

(point of curve) of a curve to the left having a radius of 55.00 feet and a central angle of 18°26'06"; thence in a Southwesterly and Southerly direction along the arc of said curve a distance of 17.70 feet to the P.T. (point of tangent) of said curve; thence tangent to said curve in a Southerly direction a distance of 82.97 feet to the P.C. (point of curve) of a curve to the right having a radius of 105.00 feet and a central angle of 18°26'06"; thence in a Southerly and Southwesterly direction along the arc of said curve a distance of 33.78 feet to the P.T. (point of tangent) of said curve; thence tangent to said curve in a Southwesterly direction a distance of 114.90 feet to the P.C. (point of curve) of a curve to the right having a radius of 105.00 feet and a central angle of 18°26'06"; thence in a Southwesterly direction along the arc of said curve a distance of 33.78 feet to the P.T. (point of tangent) of said curve; thence tangent to said curve in a Southwesterly direction a distance of 82.97 to the P.C. (point of curve) of a curve to the left having a radius of 55.00 feet and a central angle of 18°26'06"; thence in a Southwesterly direction along the arc of said curve a distance of 17.70 feet to the P.T. (point of tangent) of said curve; thence tangent to said curve in a Southwesterly direction a distance of 204.86 feet to the P.C. (point of curve) of a curve to the left having a radius of 55.00 feet and a central angle of 87°26'32"; thence in

a Southwesterly, Southerly and Southeasterly direction along the arc of said curve a distance of 83.94 feet to the P.R.C. (point of reverse curve) of a curve to the right having a radius of 72.00 feet and a central angle of 118°23'41"; thence in a Southeasterly, Southerly and Southwesterly direction along the arc of said curve a distance of 148.78 feet to the P.R.C. (point of reverse curve) of a curve to the left having a radius of 45.00 feet and a central angle of 30°57'07"; thence in a Southwesterly direction along the arc of said curve a distance of 24.31 feet to the P.T. (point of tangent) of said curve; thence tangent to said curve in a Southwesterly direction a distance of 307.13 feet to the P.C. (point of curve) of a curve to the left having a radius of 45.00 feet and a central angle of 40°14'52"; thence in a Southwesterly and Southerly direction along the arc of said curve a distance of 31.61 feet to the P.R.C. (point of reverse curve) of a curve to the right having a radius of 72.00 feet and a central angle of 80°29'58"; thence in a Southerly and Southwesterly direction along the arc of said curve a distance of 101.16 feet to the P.R.C. (point of reverse curve) of a curve to the left having a radius of 45.00 feet and a central angle of 40°15'09"; thence in a Southwesterly direction along the arc of said curve a distance of 31.61 feet to the P.T. (point of tangent) of said curve; thence tangent to said curve in a Southwesterly direction a distance of 263.14 feet to a point; thence 90°00'00" to the right in a Northwesterly direction a distance of 196.66 feet to a point; thence 95°00'00" to the lest in a southwesterly direction a distance of 111.29 feet to the P.C. (point of curve) of a curve to the left having a radius of 60.00 feet and a central angle of 70°36'50"; thence in a Southwesterly, Southerly and Southeasterly direction along the arc of said curve a distance of 73.95 feet to the P.R.C. (point of reverse curve) of a curve to the right having a radius of 70.00 feet and a central angle of 96°14'51"; thence in a Southeasterly, Southerly and southwesterly direction along the arc of said curve a distance of 117.59 feet to the P.R.C. (point of reverse curve) of a curve to the left having a radius of 60.00 feet and a central angle of 50°38'01"; thence in a Southwesterly and Southerly direction along the arc of said curve a distance of 53.02 feet to the P.T. (point of tangent) of said curve; thence tangent to said curve in a Southerly direction a distance of 320.64 feet to the P.C. (point of curve) of a curve to the right having a radius of 65.00 feet and a central angle of 43°14'23"; thence in a Southerly and Southwesterly direction along the arc of said curve a distance of 49.05 feet to the P.T. (point of tangent) of said curve; thence tangent to said curve in a Southwesterly direction a distance of 20.06 feet to the P.C. (point of curve) of a curve to the left having a radius of 55.00 feet and a central angle of 48°14'23"; thence in a Southwesterly and Southerly direction along the arc of said curve a distance of 46.31 feet to the P.T. (point of tangent) of said curve; thence tangent to said curve in a Southerly direction a distance of 578.92 feet to a point; thence 93°42'51" to the right in a Westerly direction a distance of 491.16 feet to the P.C. (point of curve) of a curve to the left having a radius of 25.00 feet and a central angle of 86°31'11"; thence in a Westerly, Southwesterly and Southerly direction along the arc of said curve a distance of 37.75 feet to the P.T. (point of tangent) of said curve, said point lying on the Easterly Right-of-Way line of Interstate Drive; thence tangent to said curve in a Southerly direction along said Right-of-Way line a distance of 446.04 feet to the P.C. (point of curve) of a curve to the right having a radius of 346.40 feet and a central angle of 17°01'01"; thence in a Southerly direction along the arc of said curve and along said Right-of-Way line a distance of 102.88 feet to a concrete Right-of-Way monument; thence 90° to the left (angle measured to tangent) in an Easterly direction along said Right-of-Way line a distance of 20.00 feet to a concrete Right-of-Way monument, said point lying on a curve to the right having a radius of 366.40 feet and a central angle of 34°28'59"; thence 90° to the right (angle measured to tangent) in a Southerly and Southwesterly direction along the arc of said curve and along said Right-of-Way line a distance of 220.51 to the P.T. (point of tangent) of said curve; thence tangent to said curve in a Southwesterly direction along said Right of Way line a distance of 7.19 feet to a point at the intersection of the Easterly Right-of-Way line of Interstate drive and the Northeasterly Right-of-Way line of U.S. Highway No. 31, said point lying on a curve to the left having a radius of 2391.83 feet and a central angle of 3°58'38"; thence 92°14'38" to the right (angle measured to tangent) in a Northwesterly direction along the arc of said curve and along said U.S. Highway No. 31 Right-of-Way line a distance of 166.03 feet to a point; thence 11°28'57" to the right (angle measured to tangent) in a Northwesterly direction along said Right-of-Way line a distance of 190.19 feet to a point; thence 18°09'03" to the left in a Northwesterly direction along said Right-of-Way line a distance of 71.92 feet to the POINT OF BEGINNING.
