

Commence at the SE Corner of Section 16, Township 22 South, Range 3 West; thence N02°25'02"W, a distance of 2635.00'; thence N90°00'00"W, a distance of 1150.44' to the POINT OF BEGINNING; thence continue N90°00'00"W, a distance of 958.33'; thence S03°08'28"E, a distance of 667.29'; thence N90°00'00"E, a distance of 797.24' to the point of curve of a non tangent curve to the right, having a radius of 50.00', a central angle of 97°42'24" and subtended by a chord which bears N32°30'28"E, a chord distance of 75.30'; thence northeasterly along the arc, a distance of 85.27'; thence N00°00'00"E, a distance of 14.07'; thence N90°00'00"E, a distance of 84.05'; thence N00°00'00"E, a distance of 588.72' to the POINT OF BEGINNING.
