

## QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the sum of FIVE THOUSAND Dollars and 00/100 (\$5,000.00) and other good and valuable consideration, in hand paid to the undersigned, the receipt whereof is hereby acknowledged, the undersigned, LUCILLE HARRIS, a single woman, and heir at law of ROSELLA MIXON AND PARALEE WALLACE, hereby remises, releases, quit claims, grants, sells, and conveys to LUCILLE HARRIS (hereinafter called Grantee), all his right, title, interest and claim in or to the following described real estate, situated in Shelby County, Alabama, to-wit:

Two acres in the SE ½ of the SE ½, Section 36, Township 21 South, Range 1 West, beginning at a point 210 yards West of the SE corner of said SE ¼ of SE ¼, running North 100 yards; thence West 100 yards; thence South 100 yards; thence East 100 yards to a point of beginning.

Six acres square in the SE corner of the SE ¼ of the SE ¼ of Section 36, Township 21 South, Range 1 West, being exactly six acres. Situated in Shelby County, Alabama.

Once acre of land off of the East side of the SW ¼ of the NW ¼ of Section 1, Township 22 South, Range 1 West, commencing at a stake at the SE corner of Belle Wallace's land and run South 72 yards; thence West 68 yards; thence North 72 yards; thence East 68 yards to the beginning point.
