ARTICLES OF ORGANIZATION

OF

TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

NAME


The name of the limited liability company ("Company") is GRUBER ENTERPRISES, LLC:



ARTICLE VIII


CONTINUATION OF BUSINESS
