KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of <u>One Hundred Seventy Thousand & 00/100 Dollars</u> (\$170,000.00) and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, that, <u>Priscilla S. Allen and husband</u>, <u>Michael S. Allen</u>, hereinafter called "Grantors", do hereby GRANT, BARGAIN, SELL AND CONVEY unto <u>Charles H. Reach and wife</u>, <u>Hazel B. Reach</u>, hereinafter called "Grantees" for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in <u>Shelby County</u>, <u>Alabama</u>, to wit:

A parcel of land in the SE¼ of the SW¼ of Section 7, Township 24 North, Range 13 East, Shelby County, Alabama, described as follows:

Commence at the Southwest corner of the SE¼ of the SW¼ of Section 7,

Township 24 North, Range 13 East, Shelby County, Alabama and run thence
Easterly along the South line of said ¼-¼ Section a distance of 668.23 feet to a point on the Westerly right of way line of Highway No. 155; thence turn 118 degrees 34 minutes 17 seconds left and run Northwesterly along said right of way line a distance of 416.24 feet to the POINT OF BEGINNING of the property being described; thence continue along last described course a distance of 208.70 feet to a point; thence turn 89 degrees 16 minutes 24 seconds left and run west-southwesterly a distance of 208.70 feet to a point; thence turn 90 degrees 43 minutes 36 seconds left and run southeasterly parallel with the right of way of said Highway No. 155, a distance of 208.70 feet to a point; thence turn 89 degrees 16 minutes 24 seconds left and run east-northeasterly a distance of 208.70 feet to the point of beginning; being situated in Shelby County, Alabama.
