### FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 10th day of March, 2004, Charita Nicole Pinkston, an unmarried woman (Charita Nicole and Charita N. Pinkston are one in the same person), executed that certain mortgage on real property hereinafter described to National City Mortgage Company dba Accubanc Mortgage, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20040325000152310, and

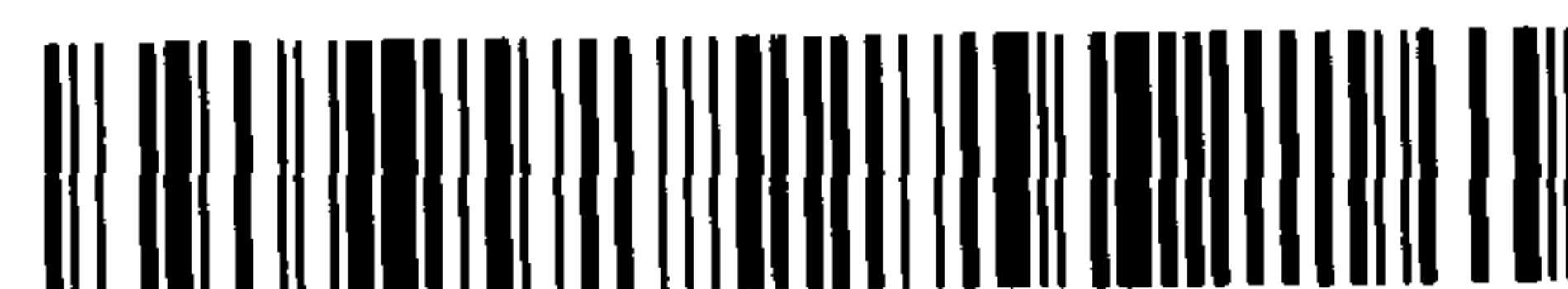




