


Legal Description

Lot 1, Springs @ Greystone, according to the plat recorded in Map Book 35, Page 96, in the Probate Office of Shelby County, Alabama.

FORMERLY DESCRIBED AS:

That certain real estate situated in D. N. Lee Estates as recorded in Map Book 3, page 115, in the Probate Office of Shelby County, Alabama, also being in the South 1/2 of the South 1/2 of Section 29 and North 1/2 of the North 1/2 of Section 32, Township 18 South, Range 1 West, being more particularly described as follows:

Commence at the Southwest corner of the Southwest 1/4 of the Southeast 1/4 of Section 29, Township 18 South, Range 1 West; thence run North along the West line of said 1/4 - 1/4 section for a distance of 309.85 feet to an iron pin set at the point of beginning, said point being on the Northwest right of way of Alabama Highway No. 119 known as Cahaba Valley Drive; thence turn an angle to the right of 27°54'59" and run in a Northeasterly direction along said Northwest right of way for a distance of 131.41 feet to an iron pin set on a curve to the left having a central angle of 3°36'08" and a radius of 5,530.14 feet; thence turn an interior clockwise angle to the right of 178°22'28" to the chord of said curve and run in a Northwesterly direction along the arc of said curve and also along said Northwest right of way for a distance of 347.69 feet to a concrete monument found; thence turn an interior clockwise angle to the right of 178°12'00" from the chord of last stated curve and run in a Northeasterly direction along said Northwest right of way for a distance of 93.82 feet to an iron pin set; thence turn an interior clockwise angle to the right of 101°23'58" and run in a Northwesterly direction for a distance of 314.01 feet to an iron pin set on the West line of said 1/4 -1/4 section; thence turn an interior clockwise angle to the right of 234°06'35" and run in a Northerly direction along the West line of said 1/4 - 1/4 section for a distance of 320.53 feet to an iron pin set at the Northeast corner of the Southeast 1/4 of the Southwest 1/4 of said Section 29; thence turn an interior clockwise angle to the right of 89°22'09" and run in a Westerly direction along the North line of said 1/4 - 1/4 section for a distance of 1,328.95 feet to an iron pin set at the Northwest corner of said 1/4 -1/4 section; thence turn an interior clockwise angle to the right of 90°37'24" and run in a Southerly direction along the West line of said 1/4 - 1/4 section for a distance of 1,077.51 feet to an iron pin found; thence turn an interior clockwise angle to the right of 89°23'23" and run in an Easterly direction for a distance of 1,296.79 feet to an iron pin found on the Northwest right of way of said Alabama Highway No. 119; thence turn an interior clockwise angle to the right of 118°32'03" and run in a Northeasterly direction along said Northwest right of way for a distance of 68.38 feet to the point of beginning.

LESS AND EXCEPT the following description:

A part of Tracts 1, 2, 3 & 4 of D. N. Lee Estates as recorded in Map Book 3, page 115, in the Probate Office of Shelby County, Alabama, and also being in the SE 1/4 of the SW 1/4 of Section 29, Township 18 South, Range 1 West, being more particularly described as follows:

Begin at an iron pin locally accepted to be the Northwest corner of said 1/4 - 1/4 section and also being the Northwest corner of said Tract 4; thence run South along the West line of said 1/4 - 1/4 section and also along the West line of Tracts 4, 3, 2 & 1 in said D. N. Lee Estates for a distance of 1,077.51 feet to an iron pin found; thence turn an angle to the left of 90°36'37" and run in an Easterly direction for a distance of 310.02 feet to a point; thence turn an angle to the left of 89°23'23" and run

in a Northerly direction for a distance of 736.70 feet to a point; thence turn an angle to the right of 20°05'51" and run in a Northeasterly direction for a distance of 189.97 feet to a point; thence turn an angle to the right of 35°41'41" and run in a Northeasterly direction for a distance of 294.91 feet to a point on the North line of said 1/4 - 1/4 section and also on the North line of said Tract 4; thence turn an angle to the left of 146°24'41" and run in a Westerly direction along said North line for a distance of 619.20 feet to the point of beginning.
