THAT, WHEREAS, heretofore, on to-wit, 28th day of July, 2003, Melissa B. Newsome as Attorney-in-Fact for the said First National Bank of Shelby County did offer for sale and sell at public outcry, at the Courthouse in Shelby County, Alabama, the property hereinafter described; and

WHEREAS, Burt W. Newsome was the Auctioneer who conducted said foreclosure sale for the said First National Bank of Shelby County; and

WHEREAS, the said First National Bank of Shelby County was the highest bidder in the


