

# EXHIBIT "A" LEGAL DESCRIPTION

### PARCEL I:

Commence at the NW corner of the NE 1/4 of the NW 1/4 of Section 9, Township 21 South, Range 1 East; thence run southerly along the West line thereof for 58.18 feet to the southerly R/W of Alabama State Highway #25; thence 88 degrees 15 minutes 50 seconds left run easterly along said R/W for 855.93 feet; thence 0 degrees 46 minutes 10 seconds left, continue along said R/W for 177.64 feet to the Point of Beginning; thence continue last described course for 266.63 feet to the East line of said 1/4-1/4 section; thence 89 degrees 19 minutes 03 seconds right run southerly along said East line for 466.47 feet to the northerly R/W of Norfolk - Southern Railroad; thence 85 degrees 52 minutes 27 seconds right run westerly along last said R/W for 266.65 feet; thence 94 degrees 03 minutes right run northerly 488.84 feet to the Point of Beginning.
