
## THE STATE OF ALABAMA SHELBY COUNTY CASE NO. PR-2005-000608



## KNOW ALL MEN BY THESE PRESENTS, THAT

Whereas, on the 1st day of April, 2002 a decree was rendered by the Probate Court of said county for the sale of the lands, herein after described, and conveyed for the state and county taxes then due from **Janice F. Burgess**, the owner of said land for the costs and expenses thereof and thereunder.
