### Legal Description:

Commence at the Southwest corner of the NE ¼ of the SE ¼, Section 31, T-19-S, R-2-W and run North 00 degrees 04 minutes 56 seconds East along the West line of the NE ¼ of the SE ¼ a distance of 541.25 feet; thence run North 55 degrees 42 minutes 20 seconds East a distance of 600.66 feet, more or less, to an existing capped iron marked SURVCONN9049 and the Point of Beginning, said point being on the Northwesterly right-of-way line of Alabama Highway #119 and the paved service road along said highway. From said Point of Beginning continue North 55 degrees 42 minutes 20 seconds East along said right-of-way line a distance of 130.65 feet to an iron pin set (1/2" rebar with cap stamped JBW&T INC. CA0046LS) on the Westerly right-of-way line of I-65 and the paved service road along side said I-65; thence run North 05 degrees 49 minutes 19 seconds East along said right-of-way line a distance of 350.00 feet to an existing PK nail in asphalt on the southeasterly right-of-way line of Cahaba Valley Parkway East; thence run South 66 degrees 06 minutes 04 seconds West along said right-of-way line a distance of 424.84 feet to an existing capped iron marked CA0010, said point being North 59 degrees 47 minutes 18 seconds East, a distance of 269.18 feet from the most Northerly corner of Lot C-2 of the Cahaba Valley Park North as recorded in Map Book 13, Page 140, Shelby County Probate Office; thence run South 44 degrees 27 minutes 33 seconds East a distance of 349.80 feet to the Point of Beginning.

Said parcel of land being a portion of the NE ¼ of the SE ¼, Section 31, T-19-S, R-2W and being the same property as described in Deed Book 2001-49861, Shelby County Probate Office, lying and being in the City of Pelham, Shelby County, Alabama, and containing 2.00 acres, more or less.
