WARRANTY DEED

STATE OF ALABAMA SHELBY COUNTY

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of **ONE DOLLAR** (\$1.00) and other good and valuable considerations to the undersigned grantors, in hand paid by the grantee herein, the receipt whereof is hereby acknowledged, we, **Lisa Kay DeLoach Barber**, a married woman, and **John H. DeLoach**, **III**, a married man, (herein referred to as grantors), do grant, bargain, sell and convey unto **John H. DeLoach**, **III**, (herein referred to as grantee), all of our undivided right, title, and interest in and to the following described real estate situated in Shelby County, Alabama, to-wit:

All that part of the following tract of land described as follows that lies West and South of Shelby County Highway #468 (Macedonia Church Road):

22 acres on the West side of the NW 1/4 of SE 1/4; part of the SW 1/4 of SE 1/4; part of SE 1/4 of S/W 1/4; part of SW 1/4 of SW 1/4; NW 1/4 of SW 1/4; NE 1/4 of SW 1/4; 35 acres in the SW 1/4 of NE 1/4; NW 1/4 of NE 1/4; all of the NW 1/4, all in Section 24, Township 18 South, Range 2 East. TO HAVE AND TO HOLD to the said grantee, his heirs and assigns forever.

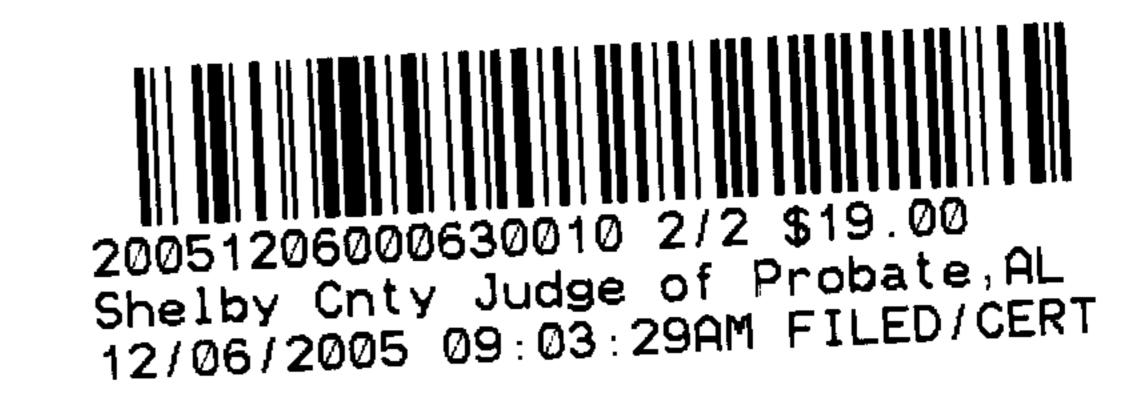
