


EXHIBIT "A" LEGAL DESCRIPTION

A parcel of land situated in the NW ¼ of the SW ¼ of Section 19, Township 20 South, Range 2 West, Shelby County, Alabama, and being more particularly described as follows:

Commence at the NE corner of the NW 1/4 of the SW 1/4 of said Section 19; thence South 00 deg. 07 min. 43 sec. East along the East line of said 1/4 - 1/4 section a distance of 507.46 feet; thence South 89 deg. 10 min. 39 sec. West, a distance of 138.96 feet; thence South 00 deg. 03 min. 46 sec. West, a distance of 72.32 feet to the Point of Beginning; thence South 00 deg. 03 min. 46 sec. West, a distance of 300.00 feet; thence North 63 deg. 35 min. 17 sec. West, a distance of 145.23 feet; thence North 84 deg. 14 min. 09 sec. West, a distance of 117.32 feet; thence South 26 deg. 39 min. 49 sec. West, a distance of 154.93 feet to the Northerly right of way line of Shelby County Highway 52; thence North 55 deg. 10 min. 38 sec. West and along said right of way, a distance of 87.37 feet; thence North 50 deg. 51 min. 19 sec. West along said right of way, a distance of 75.34 feet to the point of curve of a non tangent curve to the left, having a radius of 325,00 feet a central angle of 21 deg. 36 min. 00 sec. and subtended by a chord which bears North 16 deg. 54 min. 47 sec. East, a chord distance of 121.80 feet; thence northerly along said curve an arc distance of 122.52 feet to a point of compound curve to the left having a radius of 2,654.92 feet a central angle of 03 deg. 27 min. 43 sec. and subtended by a chord which bears North 04 deg. 22 min. 55 sec. East a chord distance of 160.39 feet; thence along said curve an arc distance of 160.42 feet; thence South 88 deg. 18 min. 09 sec. East a distance of 399.29 feet to the point of beginning, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

Subject to the following restriction, which is for the benefit of Grantor's remaining property adjacent to the above described and conveyed real estate.

The finished grade level of the following described restricted Zone A shall not exceed 495.0 feet MSL:

Commence at the NE corner of the NW ¼ of the SW ¼ of Section 19, Township 20 South Range 2 West; thence South 00 deg. 07 min. 43 sec. East a distance of 507.46 feet; thence South 89 deg. 10 min. 39 sec. West a distance of 138.96 feet; thence South 00 deg. 03 min. 46 sec. West a distance of 72.32 feet; thence North 88 deg. 18 min. 09 sec. West a distance of 310.50 feet to the point of beginning; thence continue along last described course of 93.32 feet to the point of curve of a non tangent curve to the right, of which the radius point lies North 88 deg. 20 min. 57 sec. West, a radial distance of 2,652.13 feet; thence Southerly along the arc, through a central angle of 03 deg. 27 min. 56 sec., a distance of 160.42 feet to the point of curve of a non tangent curve to the right, of which the radius point lies North 84 deg. 53 min. 14 sec. West, a radial distance of 325.00 feet; thence Southerly along the arc, through a central angle of 00 deg. 12 min. 02 sec., a distance of 1.14 feet; thence South 32 deg. 59 min. 01 sec. West, a distance of 188.93 feet to the POINT OF BEGINNING.
